Any new or remodeled residential bath completed between May 2022 and May 2024, located in a living space in the Greater St. Louis area. The project must not have been published previously and cannot be scheduled for publication prior to September 2024 (including advertisements).

**\*\*Social Media guidelines: Not published to social media 2 months prior to submission. (Company website excluded)**

**Selection Criteria:**

Judges will select winners on the basis of aesthetics, functionality, originality, design details and space planning.

**Submission Requirements:\***

In addition to this form, please submit the following:

- A half-page summary of your bath entry. (A separate entry form and summary is required for each submission.) Include the square footage, distinctive features, products/brands used, the homeowners' specifications, and challenges/solutions related to the bath space.
- Attached completed list of design suppliers and resources.
- Photos (10 max.) of the bath. If professional photos are provided, please ensure that they are high-resolution (minimum 300 dpi) and at least 8" x 10" in size and include appropriate photo credit information.
- Up to 3 8.5x11 floor plans, if possible.
- Entry fee is \$50 for first entry; \$30 for subsequent entry
- Please make copies of all materials; entries become the property of *St. Louis Homes + Lifestyles*, a publication of Network Communications, Inc.
- Maximum 5 entries per firm.

**Please omit names of clients or participating parties from materials other than on the entry form.**

**PHOTOGRAPHY TERMS** Entrants must submit only royalty/reuse-free photos.
